## Poster Contest Rules

- The 2010 Stewardship title "**Conservation Habits = Healthy Habitats**" **must be on your poster.** (*Don't use any other title*)
- Any media may be used to create a flat poster: paint, crayon, colored pencil, charcoal, stickers, paper or other materials etc
- Poster size must be between 8.5" x 11" and 22" x 28"
- All posters must be created by an individual student rather than a team of students
- No identifying information can be placed on the front of poster. No photos, personal names etc.
- Sorry no computer generated posters can be accepted
- Parent or guardian must sign entry for in order to be eligible for judging. Posters without parental/guardian signatures will be disqualified.
- **Posters are due to FSWCD office no later than March 15<sup>th</sup>, 2010; Attn: Tami Seekins, Poster Contest. Posters may be submitted prior to deadline.**

*\*\* Winning posters become property of FSWCD for approximately one year. The poster will be returned to the participant to the address provided on the entry form **after** one year.*

### **POSTER EVALUATIONS**

Posters are evaluated on the following criteria:

- Message — 50%
- Visual effectiveness — 30 %
- Originality — 10%
- Universal appeal — 10%

*Also taken into consideration is artwork completed on poster is that of participant and that it is consistent with age and grade. (Unless noted otherwise on entry form)*
